Did you know that the City offers a **free program** to get rid of unwanted cars from private property?

In the spirit of "reuse," I have to admire this person for trying their best to put this junker to work as a tree planter.

But Code Enforcement has an easier, legal and far more attractive solution for San José residents who want to get rid of unwanted vehicles - the **Voluntary Tow Program**.

While your donation won't qualify as a charitable contribution under this program, it is **free** and Code Enforcement fills out all of the DMV paperwork for you. You'll need to provide proof of ownership and ensure the car is free and clear of liens or bank loans.

Simply call Code Enforcement at 277-4528 for information or to schedule the tow. Approximately two weeks later, your tree planter will be gone, headed for dismantling!
